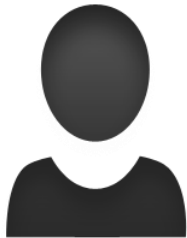

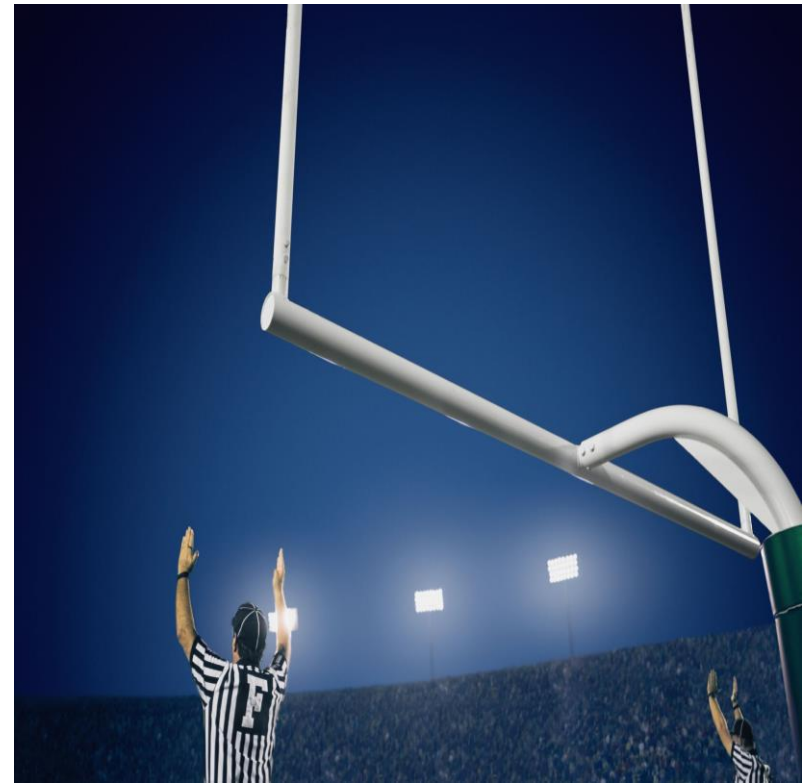
The School Improvement Process

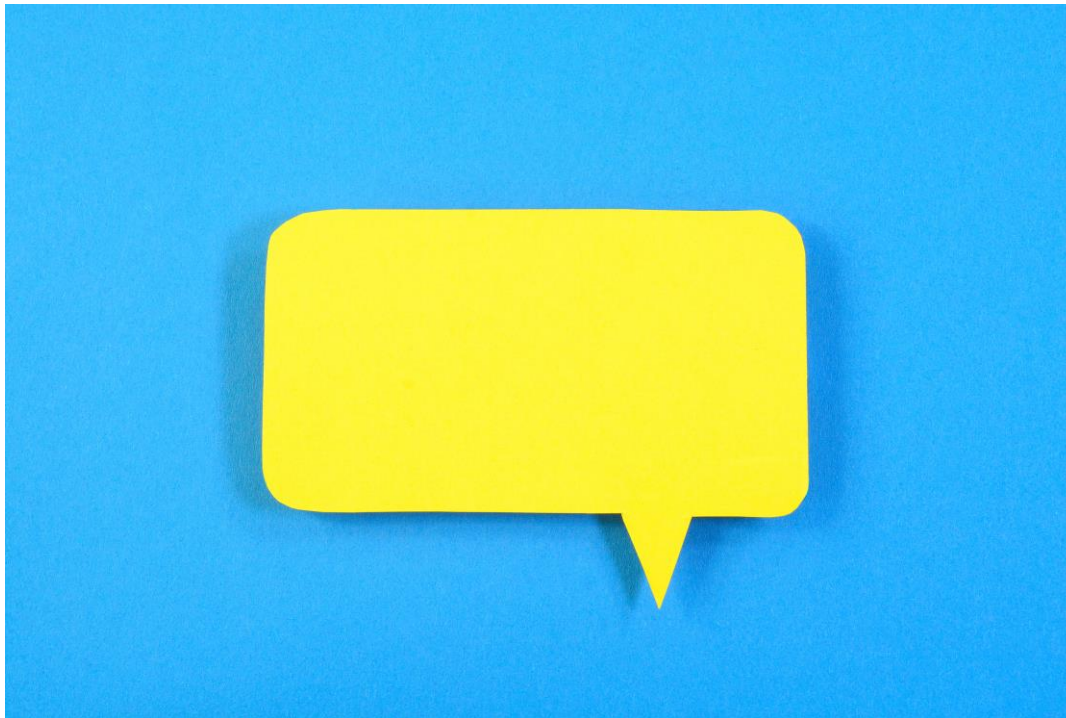
